
The TV hookup is at the bottom of the thinner gray box. Look/feel for a male screw where you can attach your coaxial.

If you're staying one (1) month or more, please take a picture of your electric meter or write down the reading so that we can get that the next day. This way we can accurately record your electric which will be due at the end of the month. This will be added to your next month's bill if you're staying several months or will need to be paid if you're leaving after one month.

We do have a take 1, leave 1 library in the office/club house. Please feel free to use it as the office/club house is open 24 hours. Just make sure you close the door and turn off lights, TV, turn up AC to 85 (if applicable) when you leave. We also have a TV, couch and table in there for you to use to relax or as a get together with other guests. Please keep it clean and tidy after use.

How to properly dispose of dishwater – Water & Electric Sites Only

In the state of Florida, dishwater is considered black water.

WHAT IS GRAY WATER?

Graywater, greywater, gray water, or grey water are all terms that have the same meaning. In this document we use the word gray water since this is what is used in both the International Plumbing Code and the Florida Building Code (ICC 2009; Florida Building Codes 2007). The exact definition of gray water varies from state to state, but generally includes any household wastewater other than that which comes in direct contact with human waste (such as water used for toilet flushing) or that has the potential to contain a large amount of organic material (such as food waste from kitchen sinks). As defined in Chapter 381 of the Florida Statutes, gray water includes water from baths, showers, clothes washers, laundry trays, and sinks, but does not include wastewater from kitchen sinks (Florida Statutes 2008). Wastewater from toilets, urinals, and kitchen drains is classified as blackwater and must be directly connected to a public sewer or to an onsite sewage and treatment disposal (e.g., septic) system (Florida Building Codes 2007). Wastewater from kitchen drains is classified as blackwater due to higher organic contents (food waste) which can lead to greater microbial activity, and thus is of greater concern to public health. In some states laundry water may be considered as blackwater when used for washing materials soiled by human waste, such as diapers.

When disposing of your dishwater, DO NOT include peelings from preparing raw vegetables, solid foods from leftover meals, paper towels, human waste, or toilet paper. The only thing that can be included are liquid foods such as soups, yogurt, etc. Peelings and solid foods must be disposed of in a plastic bag in the dumpster. Dump your dishwater down dump stations or toilets. Just make sure you follow these instructions if using toilet.

Excessive toilet paper or paper towels can and does cause septic tank backups and possible broken toilets. Consequences for inappropriately disposing of dishwater and garbage foods is a rules violation, paying for any damages/repairs and eviction depending on the severity of the issue.

Late Check-Out Policy: Management may be able to arrange a late checkout, if available. Additional fees may apply. To ensure availability for incoming guests, please plan prompt departures.

- 1. Guest assumes any and all risks associated with the foregoing and agrees to hold Management harmless from and indemnify Management against the same.
- 2. Guests and Guests are responsible for any damage or injury caused by themselves, their children and/or pets.
- 3. The park is not responsible for personal injuries or damage, loss or theft of any personal property or vehicle.
- 4. We reserve the right to evict any person(s) who does not comply with the rules and policies.
- 5. All guests and visitors must check-in at the office upon arrival.
- 6. We are an adult only (55+) campground. Children are only allowed for a short stay (2 3 days) with prior approval by management. (If you've signed a lease, lease rules supersede
- 7. this rule)
- 8. All Motorhomes, RVs or Travel Trailers must be in good working order and appearance.
- 9. We reserve the right to refuse access to any guests whose vehicle is deemed to be unacceptable.
- 10. Tent camping is permitted only in designated tent sites.
- 11. Total number of guests in any space cannot exceed the maximum capacity for that site.
- 12. Maximum of 6 people total at a site at any given time.
- 13. Visitors are welcome at guest sites between the hours of 9 am & 10 pm.
- 14. Visitors are not permitted to stay overnight unless approved by management. All visitors are required to leave by 10:00 PM.
- 15. No overnight parking or storage of trailers, boats, jet skis or utility trailers is allowed unless approved by management.
- 16. Deep fryers and tiki torches are PROHIBITED.
- 17. Vandalism of any kind by anyone in your group (regardless of age) may result in eviction from the resort.
- 18. Blowup mattresses, sleeping bags and cots are not allowed outside.
- 19. Maintenance on RV's or vehicles on property is not allowed unless approved by management.

- 20. Washing RVs or vehicles on property is not allowed unless approved by management.
- 21. The use of any paint products or chemicals is prohibited.
- 22. Clotheslines are not allowed.
- 23. Guests may not hang any items from the trees.
- 24. All sites are to be kept neat and clean for the duration of your stay. A cleaning fee of up to \$200 IF garbage is left on site, if large appliances and furniture are left to be taken to the dump, etc.
- 25. Only 1 RV and a maximum of 2 other vehicles allowed per site unless stated otherwise.
- 26. All **normal household trash** is to be disposed of in the dumpster. No large items such as furniture, refrigerators, no metal from popups, folding chairs, etc. can be disposed of in the dumpster.
- 27. DO NOT leave trash out overnight.
- 28. Boats, boat trailers, cargo trailers or car dollies are not allowed on sites. Storage is available for a fee in our storage lot.
- 29. Drones or other remote-controlled machines may not be used at any time on the property.
- 30. All guests should ensure pets and small children are always supervised.
- 31. The use of Firearms of any kind is PROHIBITED in the park.
- 32. The use of archery, paintball, slingshots, or air guns is PROHIBITED.
- 33. Fireworks of any kind are PROHIBITED.
- 34. Use of illegal drugs is PROHIBITED.
- 35. Obnoxious or abusive behavior of ANY kind is PROHIBITED.
- 36. Speed limit on property is 5-10 mph.
- 37. Motorcycles must be in idle speed when traveling through the Resort.
- 38. No vehicles can block any portion of roadway.
- 39. Vehicles may park in designated spaces only.
- 40. Only persons with a valid driver's license may operate a motor vehicle in the park, including golf carts, scooters, etc.
- 41. The park does allow the delivery of mail or packages to any guests unless approved in advance. Mail and package delivery is picked up in office by guests.
- 42. Per Florida Statute Title VI § 83.57, if you need or want to terminate your lease early, you must give notice in writing using the following notification timeline. If you do not notify the campground per the following, you will be charged a 50% penalty applicable to your site rent:
 - a) Yearlong leases require a 60-day notice to vacate;
 - b) Quarter long leases require a minimum 30-day notice to vacate;
 - c) Month-to-month leases require a minimum 15-day notice to vacate;
 - d) Week-to-week leases require a minimum 7-day notice to vacate.

Campfires and Grilling:

- 1. Campfires are only allowed in fire rings.
- 2. Do not dump charcoal on the ground or in fire rings.
- 3. Do not pour cooking oil or grease down drains, on grounds, or base of trees.
- 4. No burning of trash.
- 5. Campfires and grills must always be supervised.

Security:

- 1. Management is not responsible for lost, stolen, or damaged articles. Keep your valuables locked up.
- 2. Report any problems with your site to the Main Office immediately.
- 3. We adhere to and maintain all state, county, and local laws on property

Quiet Hours:

- 1. Quiet hours are from 8:00 PM to 8:00 AM.
- 2. Please be courteous to other guests around you.
- 3. Loud music or objectionable noise is not allowed at any time.
- 4. Inconsiderate guests will be evicted from the park.
- 5. Profanity, abuse or violence towards other guests or Resort staff will result in immediate eviction from the park.
- 6. Guests violating rules that result in an eviction notice will not receive any refunds for their stay.

Pet Policy:

- 1. We reserve the right to refuse service to anyone whose pet is NOT considered suitable to the serenity/safety of our guests or the Resort.
- 2. Pets must be kept on a leash under the control of someone who can always manage all animals.
- 3. There is a two-pet limit in the resort unless authorized prior approval by management for a three pet limit.
- 4. No exotic or oversized pets are permitted. This includes all reptiles or large birds.
- 5. All Pets must be approved by management when making a reservation. No dangerous breeds allowed.
- 6. Pets may not be left outside unattended.
- 7. Guests are responsible to "clean up" after their pets. Pet owners may be charged up to \$200 as a cleanup fee by guests that leave pet feces, holes, etc.
- 8. Guests should carry proof of pet's current vaccinations.
- 9. Resort is not responsible for and will hold accountable pet owner for any injury or damage caused by pet(s).
- 10. Service animals may accompany a disabled person without any proof of disability or certification for the service animal.
- 11. Pets are not allowed in the shower or restroom facilities.

Hobo's – **115 NW 1**st **St, Trenton**: Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt 19 for 3.0 miles, bear left onto Rt 26 for 7.7 miles, left onto NW 1st St on left

Lighthouse Restaurant (Fanning Springs) – (American) Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt 19 for 3.6 miles on left

NEARBY CITIES (from intersection Rt 349 and Rt 19)

Cedar Key – 27 miles south on Rt 19, right onto Rt 24 for 21 miles; shorter **route** take Rt 19 for 9.4 miles bear right onto Rt 341 for 2 miles, right onto Rt 345 for 18.5 miles, slight right onto Rt 24 for 9 miles

Chiefland – 10 miles south on Rt 19

Cross City – 10 miles north on Rt 19

Gainesville – start out 5 miles south on Rt 19, bear left onto Rt 26:

Trenton – 12 miles (see Hobo's restaurant for directions)

Suwannee - (from campground) 25 miles west (left) on Rt 349 to Gulf Coast

POINTS of INTEREST

Cedar Key State Park 43 miles - Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt S 19 for 9.4 miles bear right onto Rt 341 for 2 miles, right onto Rt 345 for 18.5 miles, slight right onto Rt 24 for 9 miles... watch for park signs

<u>Fanning Springs State Park</u> 5 miles - Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt S 19 for 2.2 miles, park on right... watch for park signs at entrance

Florida's Gulf Coast (see Cedar Key and Horseshoe Beach)

<u>Horseshoe/Shired Beach</u> 30 miles - Turn right onto Rt 349 for 2.25 miles, left onto Rt N 19 for 9.2 miles, turn left onto Rt SW 351 for 19 miles to Horseshoe; about 8 miles on 351, turn left onto Rt 357 to Shired

<u>Homosassa Springs State Park</u> 60 miles (best Florida view & close up to manatees on <u>floating observatory</u> - Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt 19 for 56 miles on right

<u>Ichetucknee State Park</u> 35 miles - Turn right onto Rt 349 for 24.3 miles, turn right onto US 27 for 10.4 miles on left at park entrance sign

<u>Manatee State Park</u> 20 miles - Turn right onto Rt 349 for 1.2 miles, turn right onto County Rt 55 for 1.2 miles, right onto Rt S 19 for 9.4 miles bear right onto Rt 341 for 0.6 miles, turn right onto NW 320 for 6.8 miles directly into park entrance

<u>Nature Coast State Trail</u> 2.5 miles - right onto Rt 349 for 2.25 miles, stay on 349 through light for 0.13 miles, right onto Old Town Springs Road for 0.10 miles, turn right onto NE 84 Ave to trailhead next to fire station

Suwannee River 5.4 miles – go to **Fanning Springs** bridge public parking
